**Volunteer Waiver, release and Indemnification**

- In consideration of being allowed to participate as a volunteer, I understand that in the course of my volunteer work for the *Pickering Rotary Ribfest Event*, I may come under the direction of the Rotary Club related personnel. In such an event, I (referred to as "undersigned") hereby waive, release and agree to indemnify the Rotary Clubs, the *Pickering Rotary Ribfest Event* and their directors, officers, agents, employees, committee members, and any volunteer(s) without limitation (collectively referred to as "releasees") for all claims, damages, loss and/or injury, including claims arising from the negligent acts of any of the releasees, that may result from my participation as a *Pickering Rotary Ribfest Event* volunteer.
- I understand that as a volunteer I assume all risk associated with my participation in activities and events organized and sponsored by the *Pickering Rotary Ribfest Event*, including injury, death, or illness to me and/or damage or loss to my property.
- In the event that I am unable to do so on my own because of an injury or illness I consent to administration of first aid and/or medical treatment in the event of illness or injury.**

- The relationship between the *Pickering Rotary Ribfest Event* and volunteers is strictly a volunteer arrangement and may be terminated at any time without cause by either the volunteer or the *Pickering Rotary Ribfest Event*.
- I hereby grant full permission to the *Pickering Rotary Ribfest Event*, and Rotary Clubs, to use my likeness in photographs, videotapes, motion pictures, recording or any other recording of the *Pickering Rotary Ribfest Event*, activities and/or events without compensation.
- I understand that this Waiver, Release and Indemnification is governed by the laws of the Province of Ontario and is intended to operate to benefit the releasees as well as their heirs, executors, administrators, successors and assigns, and is binding on the undersigned's as well as his/her heirs, executors, administrators, successors and assigns.
- Due to the nature of the *Pickering Rotary Ribfest Event* and in keeping with safe and responsible community best interests, volunteers might be subject to a security or volunteer reference check and will be asked to produce certification documents re: Smart Serve, First Aid and/or Police Checks.
- My signature on this Waiver, Release and Indemnification form shall serve as authorization to the Rotary Clubs to release information for the purpose of criminal background check, volunteer history and/or as required by City of Pickering re: Smart Serve approved personnel, and to use my Personal Information for the purposes of Volunteer-based communications pre, during and post Event for the current year's *Pickering Rotary Ribfest*. The Rotary Club will follow best industry practices and respect the 10 privacy principles re: life cycle management of Personal Information.
